1. PREAMBLE

In connection with the implementation of the project titled "Design and development of nanoparticle-RNA based drugs to be used in anti-cancer therapy with the construction of a nanoparticle platform for targeted delivery of therapeutic nucleic acids", by BS Biotechna SA, under contract no. 2022/ABM/06/00005-00 for co-financing of a commercial project as part of the Competition for the development of targeted or personalized medicine based on acid-based medicinal products nucleic acid and small-molecule compounds. The Ordering Party conducts market research regarding the costs of delivery and purchase of antibodies and chemical reagents.

3. DESCRIPTION OF THE SUBJECT OF THE ORDER

- 1) The subject of the order is the purchase and delivery of antibodies and chemical reagents necessary for research and development work. specified in parts 1 to 6. A detailed description is included in the assortment and price form for each part.
- 2) The Ordering Party allows the submission of partial offers - 6 parts. Due to the above, the Bidder may submit an offer for all parts or a selected part.
- 3) CPV code:
 - 33696300-8: Chemical reagents
 - 24322510-5: Ethyl alcohol
 - 33651500-3: Immune sera and immunoglobulins
- 4) The subject of the order must be brand new, of full value, complete, ready for use, free from any physical and legal defects.
- 5) The delivered assortment should be packed in the manufacturer's original packaging. During delivery, the Contractor is obliged to protect the subject of the order against damage that could affect its quality.
- 6) The subject of the order specified in the Assortment and Price Form was prepared on the basis of an analysis of supplies as part of research, scientific projects and research, experimental, development programs, etc., the continuation of which or comparison of research results, etc.,

requires the absolute use of the assortment of the same manufacturers. The names given in the description of the subject of the order define the standard required by the Ordering Party, which is necessary to continue research and compare the test results.

4. ORDER COMPLETION DEADLINE:

The expected deadline is up to 21 business days. The Ordering Party allows for an extension of the order completion date in the case of deliveries from abroad.
